#### TERMS OF BUSINESS

*Our Terms of Business include the following:*

The cost of the funeral must be paid in full 5-working days prior to the funeral service date. Failure to make payment without prior agreement from the funeral director could result in the funeral being cancelled. (A deposit is not required).

#### LATE PAYMENT

We do understand that paying for a funeral is a significant expense. If you have any concerns about payment, we ask that you make us aware at the initial arrangement, so that we can discuss help and support.

If full payment is not made by the due date (being 5-working days prior to funeral) the Company may charge interest to you on the overdue amount at the rate of 4% a year above the base lending rate of the Bank of England or Statutory Interest where applicable, which may change from time to time. The interest shall accrue on a daily basis from the due date until the date of actual payment of the overdue amount, whether before or after judgment. We may also recover (under clause 3) the cost of taking legal action to make you pay.
